## 2008 Louisville Triple Crown of Running<sup>SM</sup> presented by Novo Nordisk WAIVER

I know that running a road race is a potentially hazardous activity. I should not enter unless I am medically able and properly trained. I assume all risks associated with participating in weather, including cold, high heat and/or humidity, traffic and the conditions of the road, all such risks being known and appreciated by me. Having read this waiver and knowing these facts and in consideration of your accepting my entry to participate in the Louisville Triple Crown of Running<sup>SM</sup> presented by Novo Nordisk, which includes the Anthem 5K Fitness Classic on March 1, 2008; Rodes City Run on March 15, 2008; and the Papa John's 10 Miler on March 29, 2008 (hereinafter sometimes referred to as the "Event" and on any such date as may be determined in the event of a postponement of the Event) in Louisville, Kentucky, I, intending to be legally bound, do hereby for myself, my heirs, my executors and administrators agree as follows:

- Further, I assume the risk of all bodily injuries, including death, resulting there from, and personal injuries to me and damage to and loss of my property, including loss of use thereof and any other indirect or consequential damages, resulting directly or indirectly, wholly or in part, from my participation in the Event and while traveling to and from the Event;
- Further, I hereby agree to indemnify, defend and hold the entities specifically named in paragraph numbered 1 above harmless from and against any and all claims, liabilities, losses, damages, costs, expenses (including attorney's fees), judgments and penalties arising out of any of my acts or omissions to act;
- Further, in the event that the participant is a person under 18 years of age, the undersigned parent or legal guardian of the participant agrees to indemnify, defend and hold harmless the entities named in paragraph numbered 1 above from and against all claims, liabilities, losses, damages, costs, expenses (including attorney's fees), judgments, and penalties arising out of the participant's participation in the Event;
- Further, I understand that The Louisville Triple Crown of Running<sup>SM</sup> (Anthem 5K Fitness Classic, Rodes City Run and Papa John's 10 Miler) reserves the right to use any and all participant's names and/or likeness with regard to promotional and/or advertising materials;
- Further, I understand that all entry fees are nonrefundable and nontransferable.
